

**THE CORPORATION OF THE TOWN OF BLIND RIVER**

**BY-LAW NO. 17-10**

Being a By-Law to provide for the amendment of rates for the supply of water and water services by the Corporation of the Town of Blind River.

WHEREAS: Section 391(1), of the Municipal Act, 2001 (Ontario), as amended, provides that a local municipality may pass a by-law for imposing fees on any class of persons for services or activities provided or done by it or on behalf of it;

WHEREAS: The Council of the Corporation of the Town of Blind River deems it desirable and expedient to amend the schedule of rates charged for the use of water and water services,

NOW THEREFORE: The Council of the Corporation of the Town of Blind River ENACTS AS FOLLOWS:

- 1) That Council adopt the revised schedule of water rates and charges effective January 1st, 2017 as outlined on Schedule "A" attached hereto and forming part of this by-law.
- 2) This by-law repeals By-Law No. 16-11 passed on the 7<sup>th</sup> Day of March, 2016.

The rate for sewer service for any residential, commercial, institutional or industrial use connected to the sanitary sewer system shall be 50% of the total water charge.

**NOTE: A service fee of \$ 35.34 will be charged each time a water service is turned off and \$ 35.34 when it is turned on again. If a service is disconnected for any reason only the consumption will be affected. Basic fees for water and sewers will stay in effect until the building is demolished.**
