

CORPORATION OF THE TOWN OF BLIND RIVER

BY-LAW NO. 2168

Being a by-law to amend By-Law No. 2090 passed on the 19th day of January, 2009, being a by-law to provide for the collection, removal and disposal of garbage and other refuse within the Town of Blind River;

WHEREAS Section 11(2) of the Municipal Act, S.O. 2001, Chapter 25, as amended, gives municipalities the authority to pass by-laws respecting matters within the spheres of jurisdiction as defined in the Table to this Section;

AND WHEREAS, the Table in this Section lists waste management as a "*sphere of jurisdiction*" for single tier municipalities;

AND WHEREAS the Council of the Town of Blind River deems it necessary to establish rules and regulations governing policies relating to the disposal of garbage for residents who receive garbage pick-up services;

AND WHEREAS Council has by resolution no 10-321 passed on the 21st day of June, 2010, a copy of which is attached hereto as exhibit "A", established that effective June 1, 2011 a three bag limit will apply;

NOW THEREFORE, the Council of the Corporation of the Town of Blind River ENACTS AS FOLLOWS:

1. That the following regulations be added to Section 4 – Garbage Collection of By-Law No. 2090;
 3. Effective June 1, 2011 Three (3) bags of garbage can be placed at the curb or roadside without bag tags. All other bags of garbage must be tagged for pick-up.
 4. \$2.00 bag tags are available at the Municipal Office, 11 Hudson Street, Blind River
 5. Garbage bag sizes shall be limited to standard sizes approx. 26" x 36"
 6. A maximum of 4 regular sized garbage bags may be deposited at the Municipal Waste Disposal site during regular site open hours, without charge.
 7. Council will review the 2 bag limit proposal between June 1/11 and October 31/11.

2. That Schedule "B" of By-Law No. 2090 be replaced with the revised schedule "B" as attached hereto outlining the hours of operation for the Municipal Landfill Site.
3. This by-law comes into effect on the date of its passing.
