Being a by-law to amend By-law 23-68 for the Establishment of User Fees for  
Municipal Services for 2024.

WHEREAS Council has enacted By-law 23-68 being a by-law for the Establishment of User Fees for Municipal Services for 2024;

NOW THEREFORE the Council of the Corporation of the Town of Blind River ENACTS AS FOLLOWS:

1. THAT Schedule A be amended by adding:

Indoor Pickleball	\$49.76	Added

2. THAT Schedule C be amended by adding:

<i>Services Offered</i>	<i>2024 Fee</i>	<i>HST Included or Added</i>
After Hours Reconnection of Water (after disconnection for non-payment) Fee	\$90.78	Exempt

3. THAT Schedule E be amended by adding:

<i>Services Offered</i>	<i>2024 Fee</i>	<i>HST Included or Added</i>
Coordination Administration Fee	\$60.00	Exempt
Registration of Vacant Building Application Fee	\$400.00	Exempt
Registration of Vacant Building Annual Renewal Fee	\$400.00	Exempt

4. That Schedule F be amended by adding:



<b>Interment Charges</b>		
Adult – Monday to Friday after 3:30pm	\$900.00	Added
Infant/Child – Monday to Friday after 3:30pm	\$550.00	Added
Ashes – Monday to Friday after 3:30pm	\$600.00	Added

5. THAT Schedule K be amended by adding:

<i>Services Offered</i>	<i>2024 Fee</i>	<i>HST Included or Added</i>
<b>Non-refundable Permit Fee for commercial work per street or location:</b>		
• Road Occupancy – per lane per day	\$40.00	Exempt
• Road Occupancy – road closure per day	\$120.00	Exempt
• Road Cut	\$250.00	Exempt
<b>Deposit price per cut or excavation:</b>		
• Road Cut – asphalt road	\$2,500.00	Exempt
• Road Cut – gravel road	\$1,200.00	Exempt
• Sidewalk	\$800.00	Exempt
• Curb & gutter	\$800.00	Exempt
• Boulevard	\$500.00	Exempt

6. AND THAT the remaining provisions of By-law 23-68 shall continue unchanged without amendment and in full force and effect.
